

Survey Sample

The survey was emailed November 10th, 2015 to 950 CCIFPs and we received 95 responses. It was also posted on the CFMA forum on November 20th with exposure to 7000 members and we received an additional 80 responses. The survey was closed on December 7th with 175 respondents as follows:




Since the sample was targeted at CFMA membership and CCIFPs, the results are skewed towards larger contractors and do not represent the market in general according to the last US government census. *Note that due to the small sample sizes, data for companies with fewer than 20 employees may be statistically irrelevant.*




How many full-time equivalents (FTEs) do you have on your IT staff?

Answered: 162 Skipped: 13





Do you have a Chief Information/Technology Officer (CIO/CTO) focused on strategy?




How do you determine your annual budget for IT expenditures?

How do you determine your annual budget for IT expenditures?



- (3) Headcount plus recurring and/or special projects
- (2) IT is outsourced and fixed
- (1) Return on investment (ROI) verified by % of revenue




Considering your answer to the previous question, what percentage of your revenue is spent on IT? Answered: 160 Skipped: 15



The data shows that the majority of companies are spending much less than 1% of revenues on IT.




28 respondents selected "other" for what they include in their IT budget. Here are the summarized responses:

What do you feel is your biggest challenge related to IT?



What do you feel is your biggest challenge related to IT?



- (1) Getting management interested




Have you gotten pressure from your customer base to invest in technology? Answered: 161 Skipped: 14



Have you recently implemented a large IT-related project in the last 6-12 months or do you plan to in the next 6-12 months? Check all that apply.



It's interesting that planned BIM projects have dropped which defies published trends.


What mobile devices do you currently use in the field? Check all that apply. Answered: 160 Skipped: 15





What best describes the types of mobile devices you use in the field?




